Terms and conditions:-

1. That, Medium and place of school etc. prescribed by the institution cannot altered in future.
2. If school is started at the places other than the place permitted by the government then the permission issued by the government will be deemed to be rejected.
3. The permission to establish school under this act shall effectual since the year 2015-2016
4. That, except the classes permitted during year 2015-2016 no other classes can be stared.
5. If the school is not started within the period of month from the date of permission, then the said permission will be liable to be rejected.
6. It will be mandatory for the permitted new schools to abide by the orders and procedures passed by the government from time to time and also all the provisions of children's Right to free and compulsory Education Act 2009 and Maharashtra self- financed school (Establishment and Regulation) main Act 2012. Under Maharashtra self- financed school (Establishment and Regulation) main Act 2013.
7. It is mandatory to display a Board on the front portion of the school building mentioning new school class under self –financed Basis.
8. The school approved under Maharashtra self- financed school (Establishment and Regulation) Act 2012 will not be allowed to migrate to other places.
9. It will be mandatory for the schools permitted under Maharashtra self- financed school (Establishment and Regulation) Act 2012 to comply with the provisions of children's Right to free and Compulsory education Act 2009 and to present proposal for first approval to competent within a period of one month.
10. It will be mandatory for school permitted under Maharashtra self-financed school (Establishment and Regulation) Act 2012 to independently register themselves in UDISE as self- financed school/ Class while filling the information.

It will be mandatory to follow the government rules now existing and rules prescribed from time to time in future.
